This privacy policy applies between you, the User of this Website Ybcase.com, the owner and provider of this Website. Co Reg Asia Limited takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

### 1. Definitions and interpretation

1.1 In this privacy policy, the following definitions are used:

- 1.2 In this privacy policy, unless the context requires a different interpretation:
- 1.2.1 the singular includes the plural and vice versa;
- 1.2.2 references to sub-clauses, clauses, or appendices are to sub-clauses, clauses, or appendices of this privacy policy;
- 1.2.3 a reference to a person includes firms, companies, government entities, trusts and partnerships;
- 1.2.4 "including" is understood to mean "including without limitation";
- 1.2.5 reference to any statutory provision includes any modification or amendment of it;
- 1.2.6 the headings and sub-headings do not form part of this privacy policy.

### 2. Scope of this privacy policy

- 2.1 This privacy policy applies only to the actions of Co Reg Asia Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including but not limited to, any links we may provide to social media websites.
- 2.2 For the purposes of the applicable Data Protection Laws, Co Reg Asia Limited is the "data user" (determines the purposes for which, and the manner in which, your Data is processed, and processes the Data).

### 3. How we collect Data

- 3.1 We collect Data in the following ways:
- 3.1.1 data is given to us by you; and
- 3.1.2 data is collected automatically.

### 4. Data that is given to us by you

4.1 Co Reg Asia Limited will collect your Data in a number of ways, for example:

- 4.1.1 when you contact us through the Website, by telephone, post, e-mail or through any other means;
- 4.1.2 in each case, in accordance with this privacy policy.

# 5. Data that is collected automatically

5.1 To the extent that you access the Website, we will collect your Data automatically, for example: 5.1.1 we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

### 6. How we use your data

6.1 We may use your Data for the following purposes (including, but not limited to):

- contacting you after receiving your enquiry on the Website;
- providing you with our services;
- sending you information on your request as well as newsletters, commercial (marketing) information:
- notifying you on our organizational and technical changes;
- processing your complaints and suggestions;
- improving our services by sending out questionnaires or satisfaction forms.
- 6.2 Pursuant to Data Protection Laws we will process the minimal Data required to carry out activities stipulated in clause 6.1 hereof.

# 7. Keeping Data secure

- 7.1 We will use technical and organizational measures to safeguard your Data, for example:
- 7.1.1 access to your account (if any) is controlled by a password and a user name that is unique to you.
- 7.1.2 we use encryption software to safeguard your Data, and keep strict security standards to prevent any unauthorized or unlawful access to it;
- 7.1.3 we store your Data on secure servers to protect it against accidental loss, destruction or damage.
- 7.2 For the purposes stipulated by this policy, your Data are included and stored in our database "Clients". The database "Clients" is located on the secured servers.
- 7.3 Technical and organizational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorized access to your Data, please let us know immediately by contacting us via this e-mail address: ask@Ybcase.com

#### 8. Data retention

- 8.1 Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.
- 8.2 Even if we delete your Data, it may remain on backup or archival media for legal, tax, statistical or regulatory purposes.

### 9. Your rights

- 9.1 You have the following rights in relation to your Data:
- 9.1.1 **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
- 9.1.2 **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
- 9.1.3 **Right to be forgotten** the right to request that we delete or remove your Data from our systems.
- 9.1.4 **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
- 9.1.5 **Right to data portability** the right to request that we move, copy or transfer your Data.

- 9.1.6 **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
- 9.2 To make enquiries, exercise any of your rights set out above, or withdraw your consent to the processing of your Data (where consent is our legal basis for processing your Data), please contact us via this e-mail address:
- 9.3 If you are not satisfied with the way a complaint you make in relation to your Data is handled by us, you may be able to refer your complaint to the relevant data protection authority. - 9.4 It is important that the Data we hold about you is accurate and current. Please keep us informed if your Data changes during the period for which we hold it.

This privacy policy does not extend to your use of such websites. You are advised to read the privacy policy or statement of other websites prior to using them.

# 11. Changes of business ownership and control

- 11.1 Co Reg Asia Limited may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of Co Reg Asia Limited. Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
- 11.2 We may also disclose Data to a prospective purchaser of our business or any part of it.
- 11.3 In the above instances, we will take steps with the aim of ensuring your privacy is protected.

#### 12. General

- 12.1 You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.
- 12.2 If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 12.3 Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
